**EARLY REGISTRATION AND FEES:**

**EARLY REGISTRATION ENDS JUNE 15, 2024 WITH A FEE OF: \$125. ENTRIES MUST BE POSTMARKED BY JUNE 15, 2024**

**AFTER JUNE 15, THE VENDOR FEE INCREASES TO \$160. ANY REGISTRATION POSTMARKED AFTER AUGUST 01, WILL BE \$200. REGISTRATION FEES ARE DUE WITH APPLICATION. NO REFUNDS OF VENDOR FEES.**

EXCEPTION: If the government orders that the fair cannot open, refunds will be processed within 30 days of the scheduled event date.

**PLEASE NOTE: Your spot is not secured until your payment is received.** We only allow one of each direct sales company and limit the number of other types of booths in order to provide variety for our Fair's visitors.

**Set up will be Thursday September 5 from 10am to 7pm. Vendors must be completely set up by 7pm on the 5th.**

Each vendor space is 10x10 and in most cases, set up with the backs of the booths touching. Please note all tables are to be covered down to the floor. **Electricity is available but limited and is an additional cost of \$15.** Each vendor is in charge of bringing their own cords and cords must be taped to the floor to prevent tripping.

Vendors are allowed access to the fairgrounds one hour before opening time. **The gate watchperson does not have the authority to let you inside the gate so please do not ask.** Location of your booth can not be promised. You will receive ONE parking pass for Vendor Parking (this is limited space so first come first parked) and two (2) Admittance Passes for Each Day per Booth. **Lanyards must be worn to enter the gate and be worn at all times. Passes will be checked throughout the day.** If you need more, we will have some available for purchase (\$75 for a complete set). We have no carnival bands or tickets.
