EARLY REGISTRATION AND FEES:

WITH APPLICATION. No refunds of Vendor Fees.**

EXCEPTION: If the government orders that the fair cannot open, refunds will be processed within 30 days.

PLEASE NOTE: Your spot is not secured until your payment is received. We only allow one of each direct sales company and limit the number of other types of booths in order to provide variety for our Fair's visitors.

Set up will be Sept.7 from 10am to 7pm

Your space will be 10x10 and in most cases, you will have someone set up with the backs of the booths touching. Please note all tables are to be covered down to the floor. Electricity is available but limited at a cost (\$15 fee). You must bring cords and tape them to the floor. No inside tents are allowed (you may use the frame but not the canopy).

Vendors will be allowed access one hour before opening time provided the building has been opened and a member of the Fair committee is available to maintain security for items inside the grounds. **The gate watchperson does not have the authority to let you inside the gate so please do not ask.** Location of your booth can not be promised. We will do our best with locations. Special Accommodations are limited. Please tell us ahead of time of any special accommodations you may have.

You will receive ONE parking pass for Vendor Parking (this is limited space so first come first parked) and two (2) Admittance Bands for Each Day per Booth. **Arm bands will be numbered and checked in at the ticket booth each day by a Committee Member. Arm bands must be worn on the wrist to enter the gate and be worn at all times. Arm bands will be checked throughout the day.** If you need more, we will have some available for purchase (\$45 for a complete set). We have no carnival bands or tickets.

NOTE: When checking in and payment has been received, you will receive a vendor packet with a CMF Vendor Certificate with a Vendor's License Number. This certificate will need to be visible during the entire Fair. Please DO NOT start setting up until you have received this certificate.
